Project Overview:	Leo Lithium Limited and its Malian subsidiary Lithium du Mali SA are developing the Goulamina Lithium Project in southern Mali (the Project). The Project comprises a standard open pit mining operation with a nominal 2.5 Mtpa processing plant producing a nominal 500,000 tonnes of spodumene concentrate per annum as part of Stage 1. The Project comprises a process plant, mine and mine infrastructure, and associated non-process infrastructure. There are future plans to expand the mine site, after 18 months of production, to produce up to 800,000 tonnes of spodumene concentrate per annum as part of Stage 2.
Project Location	The Project is located in southern Mali approximately 195 km by road south of Bamako (150 km direct distance) and 50 km west of the town of Bougouni. The Project site is located between the villages of Mafèlè (3.5 km south) and Goulamina (1 km north). 
Package Description:	Provision of open pit Mining Services for the Goulamina Lithium Project (Project) for a duration of 5.5 years, based on 2.5 Mtpa for 18 months then ramp up to 4 Mtpa thereafter. Services broadly include: • Mobilisation, site establishment and demobilisation of all personnel, equipment, facilities, and services except for those identified as being free-issued or to remain on Site. • Stripping topsoil from work areas and place in stockpiles or directly onto areas prepared for rehabilitation • Fragmentation, excavation, loading, haulage, dumping and forming of Waste from the pits to specified dumps by haul truck • Fragmentation, excavation, loading, haulage, dumping and forming of ore from the pits to the ROM stockpiles by haul trucks • Pit dewatering; • Re-handle of ore from ROM stockpiles to feed the Project processing plant crusher(s), including

	breaking oversize rocks with rock breakers on the ROM pad (~800 mm); • Supply, operate and maintain front end loaders to feed the process plant primary crusher(s). • Construction and maintenance of all near and in-pit haul roads • Performance of blasting services (optional pricing), in consultation with the explosives supplier and Principal drill & blast engineer.
